MEETING MINUTES

Wednesday, October 11, 2006

Welcome and Introductions

Jeri Green, Acting Chief, Customer Liaison Office (CLO)
Melany de la Cruz-Viesca, Chair, CIC Steering Committee
Xan Wedel, Chair SDC Steering Committee

All three took turns welcoming everyone and expressing enthusiasm for a good meeting and exchange of ideas and information. Jeri thanked Stan Rolark for his dedication to the Customer Liaison Office and congratulated him on his new job. She hoped that the agenda reflected the current issues / concerns that the groups had as observed in the recent exchanges on the list serves.

Melany emphasized the importance of Census data in helping to address policy gaps. Xan also extended a welcome to the group and reiterated the importance of the meeting and that the topics and presentations should be very informative to everyone.

Greetings from the Office of the Director

Hermann Habermann, Deputy Director and Chief Operating Officer
Hermann reviewed recent Bureau activities and also outlined new staff restructuring. He also addressed that there is no definitive answer on the budget. Currently the House targeted budget would not be ample to incorporate handheld devices, while the Senate budget would most likely create a problem in the economic programs. The continuing resolution environment is also problematic since it would not provide ample funds to ramp up for 2010.

Communications Directorate Update

Jay Keller, Assistant to the Associate Director for Communications
Jay has been in this position since April of this year and he has a new boss, Ruth Cymber. He outlined her background and discussed the plans for the Bureau's communications campaign for 2010. Jay reiterated that key personnel at the Census Bureau come and go, but the SDC and CIC programs remain strong and active. Jay discussed the communication campaign for the 2010 Census, the upward trend of response rates, changes in the media industry. office in the Directorate, Public Information Office (PIO), and the continuing goal to improve relationship with SDC and CIC programs. He thanked both groups for their assistance.

2010 Decennial Census Program Update

Jay Waite, Associate Director for Decennial Census

Jay discussed the timeline for the upcoming 2010 Census, including the 2005 test and the 2008 dress rehearsals. He discussed the security that will be used, the use of Handhelds and the technology of transmitting information once an interview was completed. The 2005 test looked at race and ethnicity and the results showed that the modified version of the control worked a bit better than the control. He also discussed the contracts that have been let to Lockheed and Harris for Decennial Response Integration System (DRIS) and Field Data Collection Automation. (FDCA), respectively. American Community Survey Update

Lisa Blumerman, Deputy Chief, American Community Survey Office

Lisa summarized the history of the ACS and reviewed the procedures for the ACS; mail, phone, personal visit. She explained that the survey is mailed only in English except in Puerto Rico and that the telephone follow-up (call centers are bilingual - English and Spanish) last about 4 weeks. The ACS 2006 will have group quarters implementation and that the 2005 data was released in 4 phases: social and demographic; economic; housing; and selected population profiles. They also did a special Gulf Coast area release in response to the need for information for the areas affected by Hurricanes Katrina and Rita. (AL, MS, LA, TX). Lisa also reviewed the overview of data products for ACS and the geographies covered. In addition, she emphasized the different user guides and training materials that are available on the website. ACS Statistical Significance

Alfredo Navarro, Assistant Division Chief, American Community Survey Statistical Design

Tony Tersine, Jr. Chief, ACS Variance Estimation and Statistical Support Branch

Tony very carefully reviewed the procedures for estimating margin of error when combining or comparing two data elements. It is important to note that the margin of error that is used by the Bureau for the ACS estimates is 90 percent. Presentation available at <http://www.census.gov/sdc/www/tony.ppt>.

ACS Estimates

Signe Wetrogan,

Signe has changed positions and is now the Senior Demographic Advisor to Chief, Population Division. Her replacement is Victoria Velkoff. Signe reviewed some of the studies that are underway to look at improvements in the population estimates. She discussed the use of looking at the change in foreign born from the ACS, using IRS tax returns for domestic migration and Medicare. She also mentioned that the differential coverage accounted for most of the difference between the 2000 Census and the population estimate, with the remainder due to international migration. There will be a complete evaluation of the estimates based on the 2010 Census.

ACS Quality Measures

Debbie Griffin, Assistant to the Assistant Director for American Community Survey and Decennial Census

Debbie explained the difference between a reduction in sample size versus response rate. She also explained that the ACS language program is different than what was done in the 2000 Census. The ACS survey form is mailed in English only with Spanish upon request. The call centers employ people fluent in other languages and they want to increase the languages

covered by the call centers in order to reduce noninterview/sample reduction. Presentation available at <http://www.census.gov/sdc/www/debbieone.ppt>.

ACS Weighting

Alfredo Navarro, Assistant Division Chief, American Community Survey Statistical Design, DSSD Alfredo stated that the quality measurement website will be available by the end of October 2006. He also reminded the group that the user guide http://www.census.gov/acs/www/Products/users_guide/index.htm and PowerPoint http://www.census.gov/acs/www/Products/users_guide/acs_data_user_training.htm on the websites are very useful and provides simple explanations on how to use ACS weighting and how to evaluate the data. He also discussed the research that is underway on family equalization which they plan to incorporate into the 2006 ACS data. Alfredo also discussed the difference in using person and household weights when looking at aggregate income and he mentioned that the Bureau is looking at alternative ways to apply weights below the state level.

ACS PUMS (Public Use Microdata)

Alfredo Navarro, Assistant Division Chief, American Community Survey Statistical Design, DSSD Alfredo discussed that every year the Bureau will be releasing ACS 1% PUMS data. Next year the Bureau will provide information on how to combine PUMS data across years, but the Census Bureau will not be combining multiple PUMS data. 2005 ACS - Census 2000 Comparisons

Debbie Griffin, Assistant to the Assistant Director for American Community Survey and Decennial Census

Debbie reviewed the differences between the 2005 ACS and Census 2000. Overall, the major differences are the interview and residence rules of the target population and the time period and reference period of the data. The 2005 ACS universe is the housing unit population of the US and PR and this survey collects data on current residents (2 months or more) where as Census 2000 included group quarters and used a usual place of residence rule. The ACS uses the interview date as the single reference point, or as the end of a reference period which is similar to Census 2000, except for income, migration, and agricultural sales. Data Products

Doug Hilmer, Assistant Division Chief for Data Products

Doug wanted to invite the meeting attendees to provide comments on the first ever ACS Summary File specifications. Comments must be received by **October 31, 2006**. The document in the "document download" section of the "Guide to the ACS Data Products" page that is accessible from the Census Bureau's ACS website http://www.census.gov/acs/www/Products/users_guide/index.htm. Doug also discussed ACS data release rules and ways to access ACS data. He mentioned that the "comparison year profiles" will resume in 2008 after a number of years of group quarters data have been collected and incorporated into the product. 2007 Economic Census Update

C. Harvey Monk, Jr., Assistant Director for Economic Programs

Harvey briefed the group on the plans for the 2007 Economic Census. The economic census is the benchmark for all economic indicators including GDP and all BEA surveys. Some changes for 2007 will be an expanded detail on service products and purchased services with the collection

of data for 2200 products covering all service industries (North American Product Classification System) and the inclusion of pension and health care questions on the Business Expenses Survey. Colleen communicated with the group through remote meeting and she and Barbara LaFleur displayed the features of the system. Colleen briefed the group on the current status of the LEHD On-the-Map program, demonstrated the system, and showed the Data Ferret Hot Reports on the Internet via the remote meeting hookup. Thursday, October 12, 2006

Welcoming Remarks

Renee Jefferson-Copeland, Program Administrator State and Governmental Programs, CLO

With the first breakout session where the CICs were separated from the SDCs/BIDs, Renee took time to go around the room and allow everyone to introduce themselves. She also thanked her staff for their support during the transition/move into the new building and thanked the Regional Office staff for their support of the network.

Geographic Programs Update

Bob LaMacchia, Chief, Geography Division

Bob gave an overview of the MTAIP products and status. He mentioned that there will be a complete realignment of TIGER street centerline before 2010. BAS in 2007 will expand to cover places with population of 2,500 or more and in 2008 all government units will be included in a coordinated effort with the LUCA project. The MAF/TIGER partnership tool will be available via a PC application and BAS will have an internet-based tool as well. Bob also informed the group that this is the end of TIGER/Line - the new products will be shape files, GML, and web services.

Lessons Learned on LUCA State Pilot and Evaluation

Linda Franz, Geography Division

Linda reviewed some of the changes in the LUCA program relative to 2000. The review process will last 120 days instead of 90 days and there are 3 ways that an area can participate: Option 1 - Full Address List Review, which requires the entity to sign a confidentiality agreement; Option 2 - Provide your local address list (only city-style addresses) for Census Bureau matching and feedback (requires the entity to sign a confidentiality agreement); Option 3 - Provide your local address list (only city-style addresses) for Census Bureau matching but no feedback (no Title 13 confidentiality agreement) will be provided.

LUCA software will be provided to view list, update map, and submit changes. This software will be used for other programs too. The Bureau will invite state governments to participate for better coverage and there will be much improved training, including computer-based integrated training for the software. The tentative timeline for LUCA is shown below:

Time Frame	Activity
January 2007	LUCA Advance notice letters mailed to the highest elected official and other contacts in all active functioning governments.
July 2007	LUCA invitation letters and registration materials mailed to the highest elected official and other contacts of each government.
July 2007 to January 2008	Invited governments register for LUCA and the Census Bureau ships the LUCA review materials to each participating government.
August 2007 to March 2008	LUCA participants review and update the address list and return their comments to the Census Bureau's Regional Office.
April 2008 to October 2008	Census Bureau reviews the participant's LUCA submission and updates the Master Address File and the TIGER geographic database.
November 2008 to May 2009	Census Bureau prepares for and conducts the Address Canvassing Operation using GPS equipped hand-held computers.
June 2009 to October 2009	Census Bureau ships feedback materials to the LUCA participants showing how we processed each government's LUCA submissions.
September 2009 to December 2009	LUCA participants review their LUCA feedback and have the opportunity to appeal the results to the LUCA Appeals Office.
September 2009 to January 2010	LUCA Appeals Office reviews and adjudicates the appeals

Dan Veroff, Wisconsin SDC

Dan addressed some procedures that were tested and lessons that were learned with a pilot that was done statewide for 5 counties in WI. Wisconsin used a county parcel data base and only sent additions, not deletions to the Bureau for consideration. Some of the lessons that Dan shared were: get MAF layout now; develop a plan in collaboration with state partners; aim for statewide address list; use multiple data sources; have adequate staff and technical resources. Overall, the approach that they used worked, but statewide should be last resort, since local knowledge is better. This process made them better prepared to be a resource for the locals with the LUCA program.

Statistical Areas Update

Michael Ratcliffe, Geography Division

Michael discussed the changes that will be coming in regard to geography. He stressed that consistency is important and comparability and if they merge areas they will preserve outer boundaries; similarly if they split areas they will keep old outer boundaries. He discussed that block group data will be available for ACS and that new CDP areas will be used for 2010 and beyond. Update on Census 2010 Redistricting Data Program

Cathy McCully, Chief, Census Redistricting Data Office
Cathy presented an overview of the timeline for the redistricting data. They have collected state legislative plans and retabulated SF1 / SF3 for state legislative districts. District profiles will be out on DVD and in AFF. The reauthorization of voting rights requires a special tabulation twice per decade to determine which counties need to offer bilingual voting machines, etc. The first listing will be out in January/February 2012 for fall elections and then in 2017 using the 5-year ACS estimates. Regional Office Partnership and Data Services Update
